The Publicly Owned Utility Integrated Resource Plan Submission and Review Guidelines (Guidelines) are prepared to support the California Energy Commission's review of publicly owned utility (POU) integrated resource plans (IRP). The Guidelines provide instructions and guidance to POUs for submitting IRPs to the Energy Commission. The purpose of the Guidelines is to govern the submission of information, data, and reports needed to support the Energy Commission's review of POU IRPs.

Senate Bill 350 (de León, Chapter 547, Statutes of 2015) requires the Energy Commission to produce guidelines for and to review IRPs from POUs. Those POUs with an average load greater than 700 Gigawatt-hours (in the 2013-16 period) are required to adopt IRPs by January 1, 2019, submit them to the Energy Commission, and update them at least once every five years thereafter. Based on historical data, 16 POUs are expected to be required to file IRPs.

The Guidelines were first adopted last year at the August 7, 2017, business meeting. These Guidelines are being amended to include requirements from Senate Bill 338 (Skinner, Chapter 389, Statutes of 2017). SB 338 requires the governing board of local POUs to consider the role of existing renewable generation, grid operational efficiencies, energy storage, energy efficiency, and distributed energy resources in meeting energy and reliability needs of each utility during the hours of net-peak demand.

The Energy Commission made proposed revisions to the Guidelines to incorporate the requirements of SB 338, and held a public webinar in May 2018 to gain stakeholder input. Feedback received through the webinar and written comments were used to revise the Guidelines.

Public Comment

Oral comments. Staff will accept oral comments during the business meeting. Comments may be limited to three minutes per speaker. Any comments may become part of the public record in this proceeding.

Written comments. Written comments should be submitted to the Dockets Unit by **5:00 p.m. on July 27, 2018**. Written comments will be also accepted at the business meeting, however, the Energy Commission may not have time to review them before the conclusion of the meeting.
