Staff submits the following Status Report for the proposed San Joaquin Solar 1 & 2 Hybrid Project (SJS), pursuant to the Committee Scheduling Order dated May 7, 2009.

Current Issues and Activities for Resolution

Staff has been working through the discovery and analysis phase of the proposed SJS project Application for Certification (AFC). Staff has issued one set of data requests and received a complete set of data responses on July 15, 2009. A Data Response and Issues Resolution Workshop will be held on August 6, 2009, in Sacramento.

On June 12, 2009 Staff and the applicant met to discuss the applicant's May 20, 2009 objection to specific Data Requests from staff concerning mobile source air emissions and waste management. As a result of staff's clarification of the data requests the applicant prepared responses to each of these data requests. Staff is now reviewing the completed initial set of data responses.

Schedule

At this time staff anticipates the publication of the PSA will be delayed, reflecting the applicant's request for additional time to provide the responses to staff data requests. Staff is now working towards the following departure from the initial Committee Scheduling Order of May 7, 2009.
