California Unions for Reliable Energy (“CURE”) submits this status report, pursuant to the Committee’s May 7, 2009 Scheduling Order.

CURE submitted data requests to the Applicant on May 28, 2009 seeking copies of air quality modeling files and emission calculations in its Application for Certification (“AFC”) in electronic format. The Applicant provided responses to these data requests on June 18, 2009.

CURE submitted a second and third set of data requests on July 14, 2009 and July 27, 2009, respectively, seeking information concerning a number of issues, including the project description, alternatives, and impacts on air quality, land use, public health and safety, and from hazardous materials, noise, and waste. The Applicant’s responses to these data requests are due on August 13, 2009 and August 26, 2009, respectively. CURE may need to issue additional data requests if the Applicant’s responses to our initial data requests are incomplete, or if additional issues arise that have not yet been identified. We will review the Applicant’s responses to our data requests and follow-up on issues as quickly as possible.

CURE is also reviewing the Applicant’s draft Storm Water Pollution Prevention Plan (“SWPP”) (posted on July 16, 2009) and the Applicant’s revised air quality modeling (received on July 17, 2009), as well as the Applicant’s recent responses to the California Energy Commission Staff’s data requests.

Finally, CURE is continuing to review the AFC and may need to issue additional data requests if necessary to more fully understand the project or to assess environmental impacts, potential mitigation measures, and compliance with

all laws, ordinances, regulations and standards. CURE will identify any data requests as soon as possible after reviewing these and any forthcoming documents submitted by the Applicant.

CURE will participate in the August 6, 2009 data response and issue resolution workshop.
