Background

Public Resources Code Section 25301 requires the Energy Commission to prepare an IEPR every two years that includes assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices. The Energy Commission uses these assessments and forecasts to develop energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety.

Senate Bill 1389 (Bowen and Sher, Chapter 568, Statutes of 2002) directs state government entities to use the information and analyses contained in the adopted IEPR to carry out their energy-related duties and responsibilities. During this IEPR proceeding, the Energy Commission has coordinated closely with other agencies to ensure consistency in the underlying information used to develop this report.

As detailed in the scoping order, the *2018 IEPR Update* is composed of two volumes. The first volume, adopted on August 1, 2018, is a high-level summary of the innovative energy policies implemented in

recent years highlighting the role these policies have played in establishing California's leadership in building a clean energy future. The second volume provides a more detailed follow-up of several energy issues examined in the *2017 IEPR* and encompasses new analytical work.

The IEPR Lead Commissioner issued a scoping order on March 20, 2018, that identified topics to cover in the report. The focus areas of the *Draft 2018 IEPR Update, Volume II*, are:

- Advancing greenhouse gas reductions in California's buildings.
- Continuing work on the framework developed in response to Senate Bill 350 (de León, Chapter 547, Statutes of 2015) to double energy efficiency savings by 2030.
- Enhancing the resiliency of the electricity system while integrating increasing amounts of renewable energy.
- Working to ensure that low-income and disadvantaged communities have an opportunity to participate in and benefit from advancements and investments in energy efficiency, renewable energy, and clean transportation.
- Advancing Governor Edmund G. Brown Jr.'s call to expand state adaptation activities and consider climate change as a routine part of planning.
- Ongoing work to ensure energy reliability in Southern California.
- Updating the 2017 California energy demand forecast that was adopted as part of the 2017 IEPR.

The Energy Commission held 11 workshops between April 2018 and August 2018 on the topics identified in the scoping order. Information from the workshops and public comments were key inputs in developing the *Draft 2018 IEPR Update, Volume II*. This workshop will solicit public comments on the *Draft 2018 IEPR Update, Volume II*. Energy Commission staff will present an overview of the report, followed by an opportunity for public comments.

The Lead Commissioner will consider all oral comments from the workshop and written comments submitted to the Dockets Office. The proposed *Final 2018 IEPR Update, Volume II*, will be released January 2019 to be considered for adoption by the Energy Commission at the February 2019 Business Meeting.
