Robert Mason responded to an email inquiry attached below. In the HBEP PTA, page 5.14-2, Section 5.14.3 briefly discussed the change in how Units 1 & 2 would be demolished.

The licensed HBEP assumed that existing Huntington Beach Generating Units 1 & 2 were demolished to their foundation. The amended HBEP proposed to demolish the existing Units 1 and 2 to the steam deck. The demolition of the units will involve removal of the units and their ancillary mechanical and electrical equipment down to the concrete super structure or turbine deck level. Therefore, the volume of demolition waste would be significantly reduced. There would be less concrete and steel disposed or recycled.

The amended HBEP would produce less waste during construction. The PTA proposes to construct smaller units than the licensed project. The PTA would produce less or the same amount of waste during operation, due to the addition of the simple cycle power block.
