Dear Commissioners McAllister and Douglas:

On January 14, 2016, the Committee for the Petition to Amend the Huntington Beach Energy Project (Petition) issued a Committee Scheduling Order. The Order indicated that the parties shall file status reports on or before the first of each month, commencing February 1, 2016. Status reports shall inform the Committee whether or not case development is progressing satisfactorily and bring potential schedule delays and other relevant matters to the Committee's attention. The Committee further requested that the South Coast Air Quality Management District (SCAQMD) file status reports in the event that the timing of completion of its tasks fall outside the intervals identified in the schedule attached to the Order.

The project is currently under review by our first level supervisor and we expect that process along with secondary supervisory review to be completed and the PDOC to be issued before the end of May 2016. Once the first level supervisor review is complete, we can provide a courtesy copy of the draft PDOC for only CEC's staff review to facilitate meeting the expedited schedule for the CEC process. In addition, SCAQMD is still waiting to receive the Federal Land Manager's determination for PSD impact analysis.
