**NOTICE OF RECEIPT
PETITION TO AMEND
THE CALIFORNIA ENERGY COMMISSION DECISION FOR THE
GATEWAY GENERATING STATION (00-AFC-01C)**

On May 23, 2014, Pacific Gas and Electric Company (PG&E) filed a petition with the California Energy Commission (Energy Commission) requesting to modify the Final Decision for the Gateway Generating Station (00-AFC-01C). The combined-cycle, natural gas-fired, electricity-generating, 530-megawatt facility was certified by the Energy Commission in its Decision on May 29, 2001, and began commercial operation in January, 2009. The facility is located in the City of Antioch's Sphere of Influence, in Contra Costa County, California.

DESCRIPTION OF PROPOSED MODIFICATION

The modification(s) proposed in the petition would add additional decking to the north side of the steam turbine deck. No conditions of certification would need to be changed as part of this petition.

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality and on public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and a determination on whether the facility, as modified, would remain in compliance with applicable laws, ordinances, regulations, and standards (20 Cal. Code of Regs., § 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving, denying, or modifying the amendment proposal will be held at a regularly scheduled Energy Commission business meeting.

Any person may comment on the petition. To use the Energy Commission's electronic commenting feature, go to the Energy Commission's webpage for this facility, cited above, click on the "Submit e-Comment" link, and provide the required information in the form: Your full name, e-mail address, the comment Title, and either a comment or an attached document. The comment Title should be "[Your Name]'s Comments re: Gateway Petition." Type your comments into the "Comment Text" field, or upload and attach a document with your comments. The maximum upload file size is 10MB, and only .doc, .docx, or .pdf attachments will be accepted. Enter the CAPTCHA that is used to prevent spamming. Then click on the "Agree and Submit your Comments" button to submit your comments to the Energy Commission Dockets Unit for review. When your comments are approved and docketed, you will receive an e-mail with a link to them.
