The California Energy Commission has received a petition requesting an ownership change for the Sonoma Geothermal Power Project (80-AFC-1C). The Calpine Geysers Company, L.P., current owner of the project, proposes to transfer the license, and the obligation to perform the conditions of certification under that license to the Geysers Power Company, LLC. Both the Geysers Power Company and the Calpine Geysers Company are wholly owned subsidiary companies of the Calpine Corporation.

Commission Review Procedures

A statement describing the ownership change, signed under penalty of perjury by a representative of the proposed new owner of the project, was submitted to the Energy Commission staff for review and approval as required by Title 20, California Code of Regulations, section 1769(b). The statement affirms that the new owner agrees to be bound by the requirements of the Energy Commission Decision for the Sonoma Geothermal Power Project.

Based on the information provided, staff intends to recommend that the Energy Commission at the April 14, 1999 business meeting approve the proposed ownership change.
