Request for Additional Public Comments on Low Power Mode Data Collection Procedure

California Energy Commission staff requests supplemental information from interested parties as it considers establishing data collection procedures for low power mode (LPM) of electric appliances and electronic devices. Interested parties must submit comments to the Docket Unit by:

Background

The Energy Commission is in the early stages of establishing an energy savings roadmap for electric appliances and electronic devices in standby, idle, or general LPM. To do so, the Commission is considering collecting data to characterize LPM power draw for these products using a common data collection procedure. Although an international test procedure for standby power exists, supplemental instructions—especially those related to how the product is set up—are necessary for robust and repeatable testing.

On June 20, 2018, the Energy Commission published a discussion document that contained preliminary instructions for product testing setup, along with a list of information needed to develop a data collection procedure allowing subsequent collection of data on the performance and energy use of products while in LPM. The Commission gathered comments from the public at that time.

On January 24, 2019, staff conducted a webinar and presented a general overview of the LPM roadmap and the comments received as a result of staff's request for public comment on the "Low Power Mode Test Procedure Discussion Document." Presentation material from the webinar is available at:

The Energy Commission now seeks further information from stakeholders to develop a consensus LPM data collection procedure. Please refer to the aforementioned presentation for a list of questions and issues.

The Commission will consider all information received when developing the draft data collection procedure. There will be additional opportunities to comment on the procedure before it is finalized.
