**NOTICE OF RECEIPT  
PETITION TO AMEND  
THE CALIFORNIA ENERGY COMMISSION DECISION FOR THE  
PG&E GATEWAY GENERATING STATION (00-AFC-1C)**

On May 20, 2015, a petition was docketed with the California Energy Commission (Energy Commission) from Pacific Gas and Electric (PG&E), requesting to amend the Final Decision for the Gateway Generating Station (GGS). The combined-cycle, natural gas-fired, 530-megawatt facility was certified by the Energy Commission in its Decision on May 30, 2001, and began commercial operation on January 4, 2009. The facility is located east of the city of Antioch, in Contra Costa County, California.

**DESCRIPTION OF PROPOSED MODIFICATION**

The modifications proposed in the petition would allow GGS to install additional grating-type decking on the east side of the Steam Turbine structure, and to relocate area lighting and associated electrical power supply wiring and conduits.

**ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES**

The Energy Commission's webpage for this facility, <http://www.energy.ca.gov/sitingcases/gateway/>, has a link to the amendment petition on the right side of the webpage in the box labeled "Compliance Proceeding." Click on the "Documents for this Proceeding (Docket Log)" option.

Energy Commission staff is currently reviewing the petition. The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality and on public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and a determination on whether the facility, as modified, would remain in compliance with applicable laws, ordinances, regulations and standards (20 Cal. Code of Regs., § 1769). After the staff has completed its independent review and analysis of this petition to amend, it will publish its assessment for public review and comment.

This Notice of Receipt has been mailed to the Commission's facility mail list of interested parties and property owners adjacent to the facility site. It has also been e-mailed to the facility listserv. The listserv is an automated Energy Commission e-mail system by which information about this facility is e-mailed to parties who have subscribed. To subscribe, go to the Commission's webpage for this facility, cited above, scroll down on the right side of the project's webpage to the box labeled "Subscribe," and provide the requested contact information.

Any person may comment on the petition. 
