The South Coast Air Quality Management District (SCAQMD) received permit applications for the Redondo Beach Energy Project (RBEP) on November 21, 2012. Based on our review of the initial application package it was determined that additional information was required in order to deem the applications complete. The SCAQMD issued letters dated December 21, 2012, February 8, 2013, April 12, 2013 and June 7, 2013 requesting additional information. With the last submittal of additional information received on June 25, 2013, the SCAQMD has determined that the application package is now complete. The reference application numbers for this project and our initial review determination are provided in the table below:


