Subject: STAFF'S DATA ADEQUACY RECOMMENDATION FOR THE REDONDO BEACH **ENERGY PROJECT, (12-AFC-03)**

On November 20, 2012, AES Southland, LLC submitted an Application for Certification (AFC) to construct and operate the Redondo Beach Energy Project (RBEP). The RBEP site is located at 1100 North Harbor Drive in the City of Redondo Beach, Los Angeles County, California.

The proposed RBEP would be a natural gas-fired, combined-cycle, air-cooled 496-megawatt (MW) electrical generating facility that would be constructed on the site of, and eventually replace, the Redondo Beach Generating Station. RBEP would consist of one power block, composed of three natural gas combustion turbine generators, three supplemental fired heat recovery steam generators, one steam turbine generator, an air-cooled condenser to replace once-through cooling, and related ancillary equipment. RBEP would reuse the existing natural gas, water, wastewater, sewer and high-voltage interconnections to the site. This would avoid the need to construct any new offsite linear facilities.

The Energy Commission staff has contacted the California Coastal Commission (CCC) staff regarding the Energy Commission certification process and timeline. The Energy Commission staff is working with the CCC staff to insure their concerns are addressed as part of our review and analysis. The CCC participation is described in the 2005 Memorandum of Agreement between the Energy Commission and the CCC regarding the CCC's statutory role in the Energy Commission's AFC proceedings.

On January 9, 2013, at the Energy Commission Business Meeting, the Energy Commission found the AFC to be deficient in six areas which are: Air Quality, Biological Resources, Cultural Resources, Traffic and Transportation, Transmission System Engineering and Waste Management. On January 30, 2013, the applicant filed a Supplement to the AFC. Staff determined that a permit application completeness letter from the South Coast Air Quality Management District (District) was not provided in the Supplement to the AFC. The District provided a completeness letter to the applicant on July 9, 2013. Staff has completed its data adequacy review of the supplemental information together with the original AFC and has determined that it meets all the requirements listed in Title 20 California Code of Regulations, section 1704, Appendix B (2012) for the 12-month process.

Attached is a revised summary table and data adequacy worksheets for all technical disciplines. The revised worksheets for the aforementioned sections identify the location of the supplemental information that was provided to fulfill the AFC data adequacy requirements.

At the Energy Commission's business meeting on August 27, 2013, I will recommend that the Energy Commission accept the AFC together with the supplemental filings and appoint a Committee for the RBEP.
