CERTIFICATION OF MICHAEL C. BACHAND

1. I am the Chief Executive Officer of CalCERTS, Inc., an approved Home Energy Rating System (“HERS”) Provider for California Field Verification and Diagnostic Testing Raters, California Whole-House Home Energy Raters, and HERS Building Performance Contractors, and have personal knowledge of the facts set forth in this Certification.

5. CalCERTS is now requesting approval from the CEC for its 2019 Application which seeks approval to engage in the business of training, instructing, and certifying Raters under the 2019 Building Energy Efficiency Standards.
