## MOTION

Moved by Council Member Agajanian, seconded by Council Member Gharpetian, that the City Council's approval of Items 8(a)(1) through (9) of the July 23, 2019 City Council agenda is subject to the following conditions:

1) Glendale Water & Power (GWP) must request City Council authorization prior to purchase and installation of natural gas (Gas) units at the Grayson Power Plant and must present to City Council any new or improved technologies that develop from now until such time that may further reduce the need for Gas generation.

2) If Gas engines are installed at the Grayson Power Plant, the use of such Gas engines shall occur during situations such as peak weather or adverse system conditions.

3) If Gas engines are installed at the Grayson Power Plant, GWP shall report on Gas usage at the repowered Grayson Power Plant and make such reports available to the public on a regular basis.

4) As part of the annual Power Content Label reporting process, GWP shall report back to the City Council regarding the Integrated Resource Plan, which will include any and all developments in distributed energy resources, renewable energy, clean energy, and transmission, to identify the City's progress in meeting its SB 100 goals.

5) GWP shall update City Council on addressing Glendale's transmission and reliability challenges in order to achieve the goals of SB 100.

6) At least 60 days prior to the Council Council's consideration of the purchase of the ICE units, GWP will report to the City Council regarding the following issues:

- i. Additional Distributed Energy Resources;
- ii. Any opportunities for the City to get additional transmission capacity to serve the City's needs in helping the City reach its renewable goals as soon as feasible;
- iii. Options to renegotiate agreements with the Los Angeles Department of Water & Power regarding reserve requirements;
- iv. Options to potentially reduce or eliminate the need for the 5 units with new or improved technology prior to the Council taking action on the ICE units; and
- v. The development of a plan for goals or methods to achieve 100% clean energy by 2030.
