## Notice of Availability Glendale Water and Power Integrated Resource Plan Filing 18-IRP-01

Senate Bill 350 (SB 350) (de León, Chapter 547, Statutes of 2015) requires publicly owned utilities (POUs) with an annual electrical demand exceeding 700 gigawatt hours to adopt integrated resource plans (IRPs) by January 1, 2019. POU IRPs must be submitted to the California Energy Commission (CEC) for review by April 30, 2019. Upon receipt, the CEC will review the IRP and determine whether it is consistent with the requirements of SB 350. POU IRPs submitted to the CEC must be posted for 30 calendar days for public comment. The CEC will consider requirements in the *IRP Guidelines* as well as public comment related to the IRP during its review.

Glendale Water and Power (Glendale) is planning to replace its aging Grayson Power Plant and needed additional time to consider replacement options and respond to public comment on those options. Glendale requested a 90-day time extension to submit its IRP filing to the CEC (by July 29, 2019). The CEC granted Glendale's time extension request as the Grayson Power Plant is a large part of Glendale's resource portfolio, and understanding what resources replace the Grayson Power Plant will help CEC staff review Glendale's IRP.

On July 29, 2019, Glendale submitted its complete IRP filing and supporting information, including the four required standardized reporting tables, to the CEC. The standardized reporting tables provide data on capacity and energy resources Glendale plans to use and its projected progress towards achieving greenhouse gas emission reduction targets.

Interested stakeholders may submit written comments to the Dockets Unit by **5:00 p.m. on September 26, 2019**. The CEC is using an electronic commenting system to accept comments. Please follow the instructions below to provide written comments.

1. Go to the CEC's website: <http://www.energy.ca.gov/e-filing/>.
2. Click "Comment on a Proceeding" in the Additional Information box.

3. Type “**18-IRP-01**” into the Select a Proceeding field.
4. Click “Continue” to Add a Comment. Commenters are required to input their full name, email address, and comment title.
5. Comment title should be “Name or Company Name Comment on Glendale Water and Power’s IRP.”
6. Type comments into the “Comment Text” field or upload a document with comments. Comments should be in a downloadable, searchable format such as Microsoft® Word (.doc or .docx) or Adobe® Acrobat® (.pdf).
7. Enter the CAPTCHA that is used to prevent spamming on the website. Then click on “Agree and Submit your Comments.”
