OIR-16-05 What is a electricity product?

Electricity product(s) is mentioned twice in ARTICLE 14. Disclosure of Sources of Electrical Generation [398.1 suzy 398.5]. Once in Public Utilities Code - PUC 398.2. (b) "Retail supplier" means an entity that offers an electricity product for sale to retail consumers in California, including an electrical corporation, local publicly owned electric utility, electric service provider, and community choice aggregator. Once in Public Utilities Code - PUC 398.4. (h) as "Each of the categories specified in subdivision (g) shall be additionally identified as a percentage of annual sales that is derived from the following fuels, sources of energy, or electricity products:"

Public Utilities Code - PUC 398.4. (h) separates fuels, sources of energy, or electricity products, so electricity products are neither fuels or sources of energy.

Perhaps "electricity products" are defined by these two statutory provisions?

Public Utilities Code - PUC 398.4. (h) (6)
(6) Other categories as determined by the Energy Commission.

Public Utilities Code - PUC 398.4. (h) (7)
(7) The portion of annual sales derived from unbundled renewable energy credits shall be included in the disclosures in a format determined by the Energy Commission. A retail supplier may include additional information related to the sources of the unbundled renewable energy credits.

1391. Definitions. "Electricity portfolio" or "electricity offering" or "electric supply portfolio" appears to define "Electricity portfolio" or "electricity offering" or "electric supply portfolio" as "electricity products"

1391. Definitions.
"Electricity portfolio" or "electricity offering" or "electric supply portfolio" means the electricity products that a retail supplier offers to sell to consumers in California under terms and conditions specific to an offer or to a tariff. It does not include the provision of electric services on site, sold through an over-the-fence transaction, as defined in Section 218 of the Public Utilities Code, or sold or transferred to an affiliate, as defined in subdivision (a) of Section 372 of the Public Utilities Code.

Please define "electricity product".
