INTRODUCTION

The California Energy Commission proposes to amend the regulations for general service lamps to align with federal law and to reinstate a severability clause after considering all comments, objections, and recommendations regarding the proposed action. A written comment period was held from August 16, 2019 – October 7, 2019.

PUBLIC HEARING

On August 23, 2019, the California Energy Commission published a Revised Notice of Action (NOPA) informing stakeholders of proposed amendments to the California Appliance Efficiency Regulations for general service lamps. The revised NOPA identified October 8, 2019 as the date of the public hearing on the proposed regulations. On October 2, 2019, the California Energy Commission informed stakeholders of the postponement of the October 8, 2019 public hearing for general service lamps.

This is to inform stakeholders that Energy Commission staff has rescheduled the public hearing for the General Service Lamp regulations on the following date and time. Interested persons, or his or her authorized representative, may present oral and written statements, arguments, or contentions relevant to the proposed regulations at the hearing. The record for this hearing will be kept open until 1:00 p.m. (Pacific Time) *or until every person present, in person or via webinar, who indicates a desire to speak has had an opportunity to do so.*
