Dear Commissioner Douglas, Commissioner Scott, and Ms. Kelly:

Pursuant to Section 1716(f) of the Commission's regulations, AES Southland Development, LLC (the "Applicant") hereby files this notice of additional time needed to respond to Data Requests 8-10, 20-23, and 24 issued on October 15, 2013 by Commission Staff (Staff Data Requests, Set 1). Data Requests 8 and 9 request the Applicant to perform modeling that would simulate the potential worse-case emissions resulting from the simultaneous operation of units 5-8 and auxiliary boiler 17, and demolition of units 1-4 of the Redondo Beach Generating Station. Data Request 10 requests air quality modeling for annual impacts during the commissioning phase and subsequent operation of the Redondo Beach Energy Project ("Project"). Data Requests 20-23 request information relating to the existing baseline total nitrogen deposition rate and modeling of potential changes to the nitrogen deposition rate due to

operation of the Project. Due to the complexity of the requested modeling, the Applicant will need additional time to respond to these requests. Responses to these data requests will be provided on or before December 6, 2013.

Additional time is also needed to respond to Data Request 13. This request asks for a cumulative modeling and impact analysis for existing and planned cumulative sources located within six miles of the Project site. Before this response can be prepared, the Applicant must receive from Commission Staff approval of a list of sources to be included in the cumulative air impact analysis. The Applicant will submit a list of sources to Commission Staff on or before November 14, 2013, as part of its response to Staff Data Requests Set 1, Data Request 12. A response to Data Request 13 will be provided within six weeks after Commission Staff has approved the Applicant's proposed list of sources.
