Summary of the Proposed Redondo Beach Energy Project

The RBEP is proposed to replace the existing Redondo Beach Generating Station on a 51-acre parcel, located at 1100 North Harbor Drive in the City of Redondo Beach. The proposed RBEP is a 496-megawatt (MW) natural gas-fired, combined-cycle, air-cooled, electrical generating facility.



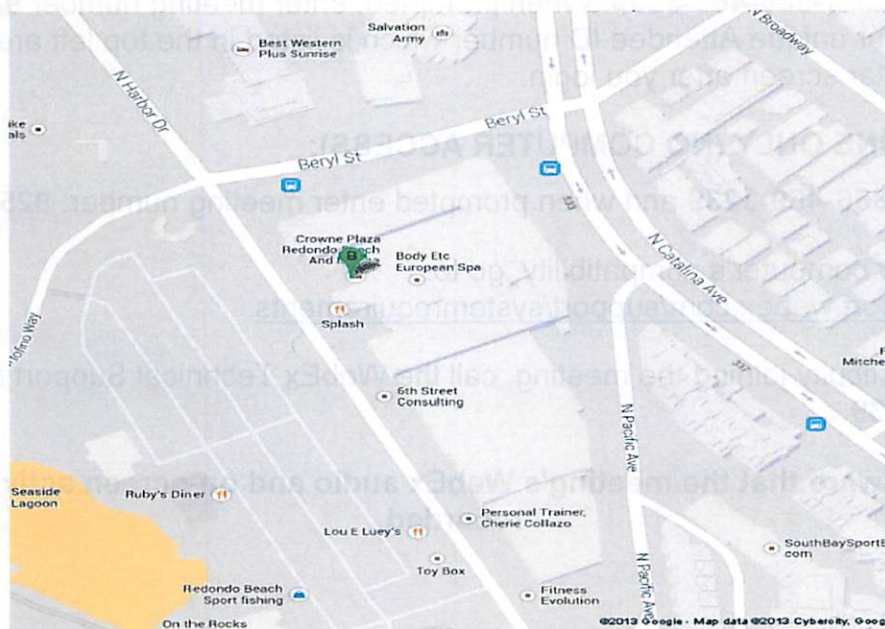
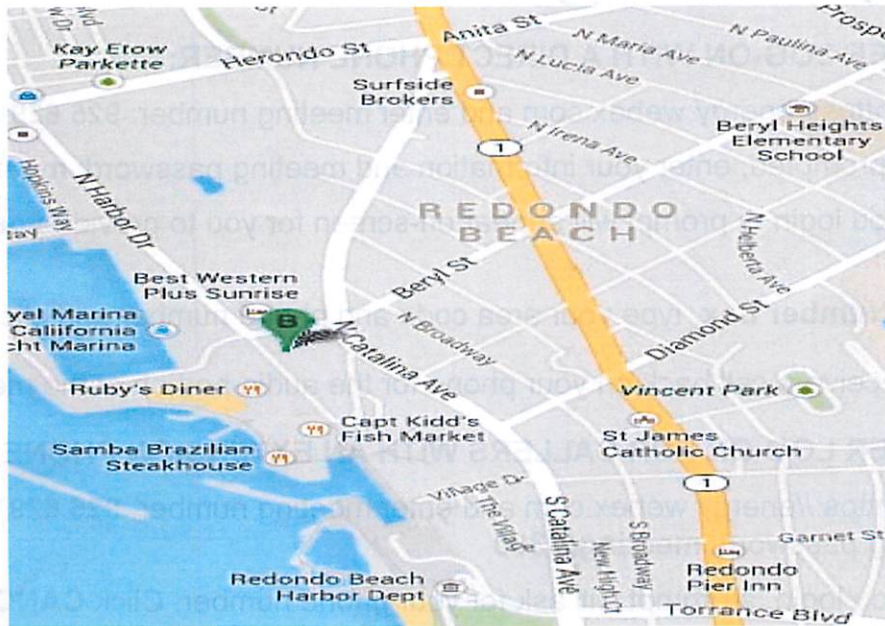
