California Energy Commission,

I strongly oppose SMUDs request to allow distant solar arrays to replace the requirement for solar on roofs. It is not equivalent. Rooftop solar keeps the owner engaged, reduces electric cost over time, reduces requirements for transmission lines, permits battery backup and does not take up other wildland for more human projects. It creates a daily reminder of the critical need to reduce energy consumption and to eliminate the use of fossil fuel.

The intention of a "community solar" program was to allow people living in close proximity to share solar: some homes may not be suitable due to orientation or shade.

Please do not consider SMUDs request. It makes a mockery of a distributed solar program and serves as a terrible example to other communities and developers.

I strongly urge you not to retreat from this important program, and require solar installations on every new rooftop in California.
