NOTICE OF RECEIPT
PETITION FOR POST CERTIFICATION PROJECT CHANGE
MAGNOLIA POWER PROJECT (01-AFC-06C)

On November 5, 2019, the Southern California Public Power Authority (SCPPA) filed a post certification petition with the California Energy Commission (CEC) for the Magnolia Power Project (MPP). The 323-megawatt combined-cycle facility was certified by the CEC in March 2003, and began commercial operation in September 2005. The facility is located in the City of Burbank, in Los Angeles County.

SUMMARY OF PROPOSED CHANGES

SCPPA is proposing to upgrade (modify) the existing MPP combustion system that will allow improved combustor turndown. This upgrade will allow the MPP to generate power over a wider operating range of the gas turbine from about 27% load to full load. The ability to operate over a broader range will increase the operating flexibility of the MPP to better integrate with intermittent renewable energy resources (e.g. wind and solar).

These proposed changes will be made while continuing to meet the existing and modified Title V permit emission limits without increasing the following:

- (1) fuel-input limits and power generating capacity, or
- (2) the potential to emit of criteria pollutants, greenhouse gases, and air toxics.

This Notice of Receipt has been mailed to the facility's mail list of interested parties and property owners adjacent to the facility site. The petition requesting the project change has been docketed and is available on the CEC's webpage for this facility at:

REVIEW PROCESS

The review process includes an evaluation of the change and the possible significant effect on the environment, compliance with applicable laws, ordinances, regulations or standards and if a change to or deletion of a condition of certification is required.

After staff has completed its independent review and analysis of this petition, staff will publish an assessment for public review and comment. Staff will also provide written notice of its intent to either process the proposed changes as a staff approved project change or schedule the project change to be heard for consideration by the CEC at a regularly scheduled business meeting.
