Dear Director Bohan:

We respectfully request to amend our Application as a HERS Provider for the 2019 Building Energy Efficiency Standards to reflect our recent name change from ConSol Home Energy Efficiency Rating Services (CHEERS) to California Energy Registry. An amendment to our Articles of Incorporation was filed with the California Secretary of State on September 25, 2019. Cal Energy was filed as a corresponding fictitious business name with Sacramento County on October 30, 2019. We intend to use both California Energy Registry and Cal Energy going forward.

The name change reflects our desire to have a greater impact on sectors of the California building market that (1) are unsure or unaware of their obligations to comply with California energy code or (2) actively choose to circumvent energy code requirements. We believe active outreach to homeowners, contractors and other market stakeholders will be more effective coming from California Energy Registry and Cal Energy.
