Pursuant to the Committee Scheduling Order issued on October 16, 2013, AES Southland Development, LLC (the "Applicant") hereby files this monthly status report to inform the Committee on the progress of the Redondo Beach Energy Project ("Project") Application for Certification ("AFC") proceeding. This report describes activities that have occurred since Applicant's Status Report # 3 was filed.

I. SCHEDULE

The South Coast Air Quality Management District ("SCAQMD") is expected to issue the Preliminary Determination of Compliance ("PDOC") soon. Once the PDOC is issued, the Committee Schedule calls for the Staff to publish the Preliminary Staff Assessment within 45 days thereafter.

II. WORKSHOP

On February 10, 2014, the Staff conducted a public workshop in Redondo Beach.

III. DATA REQUESTS/RESPONSES

A. Staff Data Requests

1. Data Request 13, Staff's Data Request Set 1A

The Applicant continues to work with the South Coast Air Quality Management District ("SCAQMD") to obtain emissions data needed to respond to Staff's Data Request 13. The Applicant received a portion of the data from SCAQMD. Based on discussions with the SCAQMD modeling staff, the Applicant submitted a Public Records Act request on February 28, 2014 for the remaining data. The Applicant expects to submit a proposed

methodology to Staff in late March. The Applicant will submit a response to Data Request 13 within 6 weeks of Staff's approval of the methodology.

**2. Data Request 72, Data Request Set 4**

On February 24, 2014, Staff filed Data Request Set 4, consisting of one data request regarding Noise. The Applicant is reviewing the data request, and will respond within the time provided for in Section 1716 of the Commission's regulations.

**B. City of Redondo Beach Data Requests**

On February 24, 2014, the City of Redondo Beach (the "City") filed data requests to the Applicant. The Applicant is reviewing the data requests, and will submit a response within the time provided in Section 1716 of the Commission's regulations.

**IV. CONCLUSION**

The Applicant looks forward to the timely submission of the PDOC and PSA.
