PETITION FOR POST-CERTIFICATION PROJECT CHANGE AMENDED CARLSBAD ENERGY CENTER PROJECT (07-AFC-06C)

On February 3, 2020, the Carlsbad Energy Center, LLC, the project owner, filed a post certification petition with the California Energy Commission (CEC) for the Amended Carlsbad Energy Center Project (ACECP). The 527-megawatt (MW) peaking power plant was certified by the CEC in July 2015, and began commercial operation in December 2019. The facility is located at 4600 Carlsbad Boulevard in Carlsbad, San Diego County.

SUMMARY OF PROPOSED CHANGES

The project owner is seeking CEC's approval of a Petition to Amend ACECP Air Quality Conditions of Certification AQ-14 to modify the turbine shutdown condition definition without a change in permitted shutdown emissions limits and AQ-40 to modify the permitted carbon monoxide (CO) startup mass emission limit.
