**REDONDO BEACH ENERGY PROJECT
STATUS REPORT # 5**

Pursuant to the Committee Scheduling Order issued on October 16, 2013, AES Southland Development, LLC (the “Applicant”) hereby files this monthly status report to inform the Committee on the progress of the Redondo Beach Energy Project (“Project”) Application for Certification (“AFC”) proceeding. This report describes activities that have occurred since Applicant’s Status Report # 4 was filed.

I. SCHEDULE

The South Coast Air Quality Management District (“SCAQMD”) has all the information needed to issue the Preliminary Determination of Compliance (“PDOC”) for the Project. It is the Applicant’s understanding that the PDOC is being drafted and expected to be under review by SCAQMD management in early April.

II. DATA REQUESTS/RESPONSES

A. Staff Data Requests

The Applicant has completed its responses to all data requests submitted by Staff, with the exception of Data Requests 12, 13, and 23. The responses to these data requests are all contingent upon the Applicant receiving emissions data from SCAQMD.

On February 28, 2014, the Applicant submitted a Public Records Act request to SCAQMD to obtain the emissions data. While the Applicant has received some data, the Applicant continues to work with SCAQMD to obtain all of the necessary emissions data.

Once the Applicant receives all of the necessary data, the Applicant expects to be able to submit a proposed methodology and data responses within two weeks of receipt of the data, and complete all responses within 6 weeks of Staff's approval of the methodology.

B. City of Redondo Beach Data Requests

On February 24, 2014, the City of Redondo Beach (the "City") filed data requests to the Applicant. On March 17, 2014, the Applicant provided responses to the City's data requests, in addition to a notice of objection to certain requests.

III. CONCLUSION

The Applicant looks forward to the timely submission of the PDOC and PSA.
