## Strong Support for Reach Codes across All Nine Local Jurisdictions

Dear California Energy Commissioners,

On behalf of Carbon Free Silicon Valley ("CFSVâ€□), this comment expresses our strong support for the proposed Local Ordinance Applications that will be considered tomorrow, February 20th. We urge you to approve each clean energy "Reach Codeâ€□ local ordinance for Santa Rosa, Berkeley, Windsor, Mountain View, Windsor, Milpitas, Healdsburg, Palo Alto, Los Gatos, and Brisbane.

CFSV is a regional collaboration of local climate leaders in Silicon Valley. Together we work with our local clean energy agencies, municipal utilities, and elected officials across Santa Clara and San Mateo Counties to ensure Silicon Valley leadership in achieving aggressive greenhouse gas reductions. We seek a thriving, carbon-free Silicon Valley, especially since what we do in our well-known area can help lead others in our State and across the U.S. to follow our regional example.

Many members of our group have had direct involvement in educating local public officials about the benefits of all-electric, or at least mostly-electric, new construction, and have advocated for these important Reach Codes in five of these nine local jurisdictions.
