FULL NOTICE TO PROCEED FOR DECOMMISSIONING AND DEMOLITION  
PLAN ACTIVITIES**

Dear Mr. Escobedo:

The California Energy Commission (CEC) staff and the Delegate Chief Building Official (DCBO), Todd Bailey, P.E., LEED AP, CASp, MBA of TRB and Associates, have finished the review of the pre-decommissioning/demolition requirements for the Inland Empire Energy Center (IEEC). All required pre-demolition condition of certification submittals are satisfactory. Staff is issuing this Notice to Proceed as authorized in the December 2003 Final Commission Decision for IEEC. Staff has determined that decommissioning and demolition activities associated with IEEC may commence.

All decommissioning and demolition activities shall be carried out in accordance with:

- IEEC's November 11, 2019 Revised Closure Plan prepared pursuant to General Compliance Condition COM-12, and approved by the Commission in its Adoption Order on December 11, 2019.
- The Agreement #: 700-19-005 between the Energy Commission and the DCBO, TRB and Associates, Inc.
- The Delegate Chief Building Official Agreement – 01-AFC-17C – signed on January 27, 2020 between TRB and Associates ("DCBO") and Inland Empire Energy Center, LLC, a Delaware limited liability company ("Owner").

All construction activities shall follow all applicable federal, state and local requirements. Lack of conformance with the conditions of certification identified in CEC staff's *Inland Empire Energy Center Closure Plan: Staff Analysis and*

*Recommendation*, and the conditions contained in the Closure Plan Adoption Order may result in suspension of demolition activities.
