NOTICE OF CANCELATION OF COMMITTEE CONFERENCE AND ORDER TO FILE LATE RESPONSE

On November 15, 2019, Microsoft Corporation (Applicant) submitted an application for a small power plant exemption (SPPE) for the San Jose City Backup Generating Facility to the California Energy Commission (CEC).¹

On February 27, 2020, the Committee² assigned to conduct these proceedings received a request from Applicant to reschedule the Committee Conference previously set for Wednesday, March 4, 2020.³ The Committee granted the request and rescheduled the Committee Conference to March 17, 2020.⁴ However, the Applicant did not comply with the Committee's request to file a response to Staff's Issues Identification Report, Status Report, and Proposed Schedule by March 13, 2020. The Applicant also did not timely file a response to Staff's Motion for Leave to File Additional Data Requests (Motion), filed February 28, 2020.⁵

The Committee understands that these are uncertain times and that there may be compelling reasons that explain this delay. Nonetheless, given the lack of a response from Applicant to either Staff's Issues Identification Report, Status Report, and Proposed Schedule or Staff's Motion, the Status Conference scheduled for March 17, 2020, is hereby **CANCELLED**.
