## NOTICE OF STAFF WEBINAR

California Energy Commission (CEC) staff will conduct a pre-solicitation workshop via WebEx™ to solicit feedback on a draft concept for Zero-Emission Transit Fleet Infrastructure Deployment.

Staff has released a “Draft Solicitation Concept” document, which details the concept under consideration for a competitive grant solicitation to be issued by the CEC’s Clean Transportation Program. The purpose of this solicitation is to provide capital assistance for make-ready equipment upgrades and zero-emission vehicle (ZEV) electric vehicle charging or hydrogen refueling infrastructure to support the roll-out of medium- and heavy-duty (MD/HD) zero-emission transit bus fleets. The goal of the solicitation will be to fund the infrastructure for one to two large-scale transit projects, for the transit bus fleet conversion of at least 50 buses.

### Background

Assembly Bill 118 (Núñez, Chapter 750, Statutes of 2007), created the Clean Transportation Program (formerly known as the Alternative and Renewable Fuels and Vehicle Technology Program). The statute authorizes the CEC to develop and deploy alternative and renewable fuels and advanced transportation technologies to help attain the state’s climate change and clean air goals. Assembly Bill 8 (Perea, Chapter 401, Statutes of 2013) reauthorized the funding program through January 1, 2024.

The Clean Transportation Program Fiscal Year (FY) 2018-19 and 2019-20 Investment Plans dedicated \$17.5 million and \$30 million, respectively, under the Advanced Freight and Fleet Technologies category, to medium- and heavy-duty (MD/HD) zero-emission vehicles (ZEVs) and ZEV infrastructure.

Staff held a pre-solicitation concept workshop on October 25, 2019, to solicit feedback from stakeholders on various proposed solicitation concepts for MD/HD applications. This workshop garnered over 150 participants, both in-person and online, including attendees from government agencies, utilities, vehicle manufacturers, transit agencies, and ports. Staff received feedback at the workshop in addition to comments submitted to the docket.

Based on workshop input and written comments, staff has developed a “Draft Solicitation Concept” for Zero-Emission Transit Fleet Infrastructure Deployment, which will target public transit agencies in need of capital assistance for new ZEV infrastructure or upgrades of existing infrastructure.

This workshop seeks:

- To provide information about the draft solicitation concept.
- To gather public input to the draft solicitation concepts.
- To respond to public questions.

Following the workshop, staff will release a solicitation schedule and a final solicitation.

## **Public Comment**

**Oral comments:** Staff will accept oral comments during the workshop. Comments may be limited to three minutes per speaker and one speaker per organization. Any comments may become part of the public record for this proceeding.

**Written comments:** Written comments must be submitted to the Docket Unit by **5:00 p.m. on April 24, 2020.**

Written and oral comments, attachments, and associated contact information (that is, address, phone number, email address) become part of the viewable public record. This information may also become available via any Internet search engine.
