INTRODUCTION

On February 20, 2020, the California Energy Commission (CEC) published a Notice of Proposed Action (NOPA) proposing energy efficiency regulations related to replacement dedicated-purpose pool pump motors (RDPPPM) and dedicated-purpose pool pumps (DPPP). The NOPA identified **April 7, 2020 at 10:00 a.m. (Pacific Time)** as the date for the public hearing and provided instructions for attending the hearing, including in person.

In accordance with direction from California Department of Public Health to encourage social distancing in order to slow the spread of COVID-19, **the CEC has converted this hearing to be an online hearing only. Interested persons may participate and comment online or by phone via Webex.** Revised instructions for remote participation are provided below.

Pursuant to Executive Order N-29-20 Commissioners may participate remotely. The public may observe, provide public comment during the public comment periods, and otherwise observe remotely in accordance with Bagley-Keene Open Meetings Act as described below.
