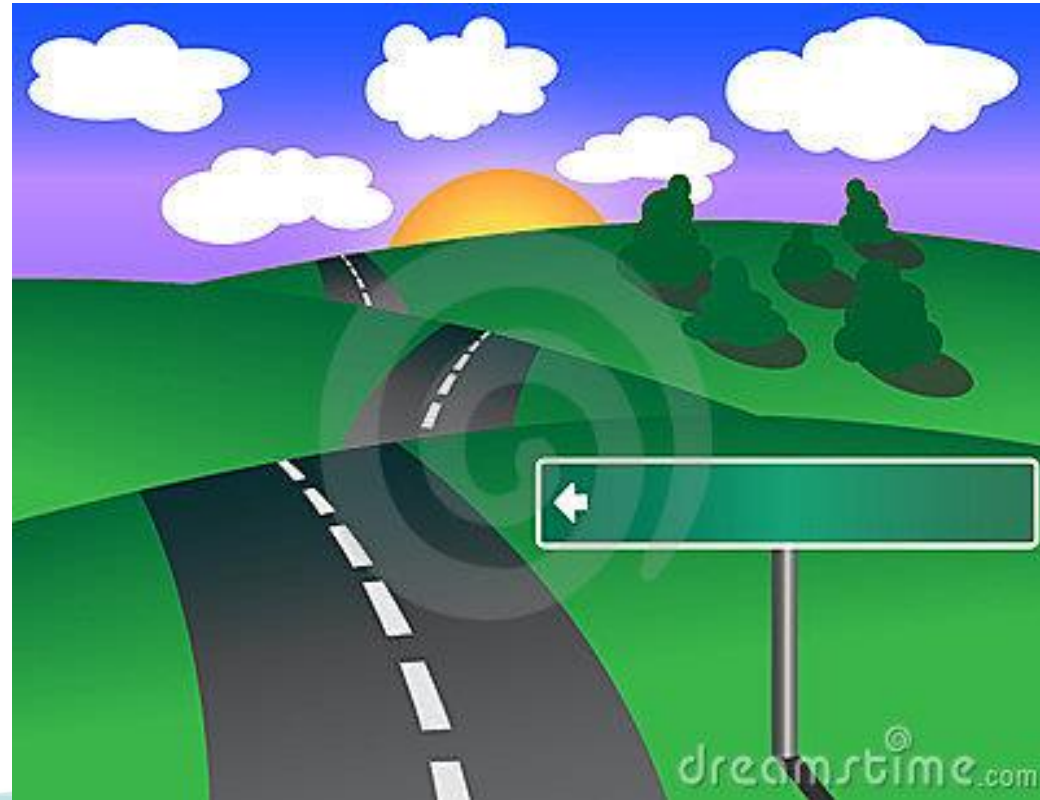

About CEC's Public Advisor

- Statutorily-mandated role (Warren Alquist Act, Public Resources Code §25217.1)
- Licensed attorney nominated by CEC and appointed by Governor for 3 years
- Duties (PRC §25222):
 - Help public understand CEC processes
 - Assist public to participate in proceedings
 - Recommend to CEC approaches to engage public
 - Ensure timely notices to public
 - Identify and conduct outreach to stakeholders
 - Assist with access to language services and reasonable accommodations

Outreach Conducted for San Jose City SPPE

- **Notice of Receipt** mailed to residents within 1,000 ft. of project site, California Native American tribes associated with the project area, among others (mailing list to be published in environmental assessment doc)
- **Notice of Committee Conference** emailed to parties to the proceeding and sent via listserv
- **All notices are docketed**
- **Additional Outreach to Stakeholders** via mailing, email or phone:
 - Local & state elected representatives; air, water and transit district officials, parks & rec departments
 - Community-based organizations, environmental and social justice advocates, health groups
 - Daycare centers, libraries, schools and school districts, religious organizations
 - Community centers, chambers of commerce, trade associations, labor groups



“Informal” Participation

- Attend events (NOTE: proceedings will be remote until further notice)
- Methods to make public comment:
 - Speak during public comment period;
 - Public Advisor may relate points; and
 - Submit written comments to Docket Unit



“Formal” Participation

- **Become an Intervenor**, a person or group that is a “party” to the proceedings who may:
 - Present evidence and witnesses
 - Object to other parties’ evidence
 - Cross-examine other witnesses, and
 - File motions
- **File Petition to Intervene**
 - Anyone may file; not necessary to be attorney or have legal representation (CCR, §§1206 & 1211.7)
 - No specific form but must provide required info in petition (CCR, §1200.7(a))
 - File early to meet filing and discovery deadlines set by Presiding Member (CCR, §1211.7)
 - File in the Docket and include the docket number
