**REDONDO BEACH ENERGY PROJECT
STATUS REPORT # 15**

Pursuant to the *Revised Committee Scheduling Order* issued on May 7, 2015, AES Southland Development, LLC (the “Applicant”) hereby files this status report to inform the Committee on the progress of the Redondo Beach Energy Project (“Project”) Application for Certification (“AFC”) proceeding.

On June 4, 2015, the Applicant submitted comments on the Preliminary Staff Assessment (“PSA”), which included an updated construction and demolition schedule and Site Screening and Landscape Concept Plan. On June 19, 2015, the Applicant submitted the updated Key Observation Point simulations requested by Staff on May 27, 2015 (*See*, TN#: 20478). On June 19, 2015, the Applicant filed an air dispersion modeling inventory for the existing and planned cumulative air quality sources within six miles of the Project as part of Data Response Set 1D (*See*, TN#: 205093). Once the Applicant receives approval of the list of sources and associated modeling parameters from Staff, the Applicant will provide the cumulative modeling and impact analysis requested in Staff’s Data Request 13.

The Applicant has also provided the following clarifications in responses to information requests from Staff.

First, the Applicant confirmed the approximate timeline for the construction and demolition of the Project (*See*, TN#: 205092).

Second, the Applicant clarified that the RBEP site will consist of a new, single legal parcel of approximately eleven acres (*See*, TN#: 205095). The Applicant intends to

obtain a lot line adjustment to create this parcel prior to the commencement of construction, as set forth in proposed Condition of Certification LAND-1 in the PSA.

The Applicant has also received a data request from the City of Redondo Beach that requests technical data relating to noise. The Applicant is currently reviewing this request.
