Notice of Staff Workshop on Counting Electric Vehicle Chargers in California

California Energy Commission (CEC) staff will host a remote-access workshop to solicit stakeholder feedback on methods to count public and shared private electric vehicle chargers in California. The workshop will present current and planned efforts to count chargers, existing data sources for charger inventory, gaps in data, and proposed methods to count chargers. A quorum of commissioners may participate, but no votes will be taken.

The workshop will be held remotely, consistent with Executive Orders N-25-20 and N-29-20 and the recommendations from the California Department of Public Health to encourage physical distancing to slow the spread of COVID-19. The public can participate and observe the workshop consistent with the direction in these Executive Orders. Instructions for remote participation are below.

Background

Executive Order B-48-18 (signed January 2018) set infrastructure targets of 250,000 electric vehicle chargers, including 10,000 direct current fast chargers by 2025. The 250,000-charger

target includes both publicly available and private shared chargers (e.g., workplace and multi-family housing).

Having a reliable view of the number of both publicly and privately shared chargers in California will help the CEC and others improve public and private investment decisions.

Several sources of charger data are available, but none is comprehensive. In particular, data is incomplete for “private shared” chargers such as workplace chargers serving multiple vehicles but not publicly accessible. This lack of data creates challenges from both policy and planning perspectives, especially if most of the charging happens at home and at work. This will also help CEC get to an aggregate count of chargers in California to show progress towards the 250,000-charger target.

The workshop seeks to gather public input on:

- Charging definitions proposed by staff.
- Methods to count public and private chargers.
- Barriers to collecting charger counts.
- Other data sources for charger inventory.
- How to avoid double counting chargers.
