Hi Eileen and thanks for your email requesting an update on the timing of the SCAQMD's issuance of the Final Determination of Compliance (FDOC). Eileen, as you may know, subsequent to the SCAQMD's Public Consultation meeting held on June 25, 2015 and SCAQMD's July 30, 2015 status report referenced in your email, the U.S.EPA promulgated the Clean Power Plan Rule for both New and Modified, as well as existing power plants. In addition, on August 7, 2015 AES RBEP submitted new information related to the updated MET data that impacts the modeling analysis for the proposed project. The SCAQMD staff needs to evaluate the AES RBEP compliance with the Clean Power Plan Rule and re-evaluate the modeling analysis, especially during the commissioning and subsequent simultaneous start ups of multiple gas turbines to determine compliance with both National and California Ambient Air Quality Standards for this project.

At this time it is anticipated that these further analysis and issuance of the FDOC will be in late 2015 or early 2016. As we further complete our evaluation, I can give you a more accurate time frame for issuance of the FDOC. Please let me know if you have any further questions or need any additional information. Thanks.
