- 2. If no opposition to this Order is filed by the deadline specified above, this Order will be deemed final and effective as of 12:01 p.m. on June 10, 2020.
- 3. Should this Order become final by separate ruling of the Committee or as specified in list item 2 above, then Mr. Sarvey may give testimony in the June 15, 2020 evidentiary hearing only if he files opening, and/or reply testimony no later than 5:00 p.m. on June 11, 2020 and in addition, to participate in the evidentiary hearing, he must file a prehearing conference statement and an exhibit list (if he has any exhibits) no later than 5:00 p.m. on June 11, 2020. For further requirements for the Prehearing Conference statement, please see the "Revised Notice of Prehearing Conference and Evidentiary Hearing, Scheduling Order, and Further Orders," filed on June 5, 2020.⁵
