# PETITION FOR POST CERTIFICATION PROJECT CHANGE GEYSERS SONOMA, UNIT 3 (80-AFC-01C)

On April 1, 2020, the Calpine Corporation filed a post certification petition with the California Energy Commission (CEC) for the Geysers Sonoma, Unit 3 project. The 78-megawatt (MW) project was certified by the CEC in March 1981 and began commercial operation in December 1983. To install a permanent standby skid-mounted diesel engine-powered pump as part
