El Segundo Energy Center LLC ("ESEC LLC") has worked diligently to provide thoughtful, thorough responses to Staff's questions related to ESEC LLC's Air Quality, Biological Resources, Cultural Resources, Socioeconomics, Geological Resources and Waste Management data since the California Energy Commission Staff's ("Staff") October 1, 2013 Data Request, Data Response and Issue Resolution Workshop for the Petition to Amend the El Segundo Energy Center project (00-AFC-014C) (the "Project"). On October 22, 2013, Staff docketed its Data Request Set 4. ESEC LLC responded to these data requests on November 13, 2013. ESEC LLC docketed a Phase I Environmental Site Assessment on October 30, 2013, in response to Staff's Data Request 87, and docketed its responses to Staff's Data Request Set 3 on October 31, 2013. More recently, ESEC LLC provided Staff with supplemental data related to Air Quality and Cultural Resources.

During this time, ESEC LLC also responded to Staff's Data Request Sets 3 and 4, and provided Staff with copies of ESEC LLC's November 5th and November 7th correspondence with the South Coast Air Quality Management District (the "**District**"). This correspondence with the District contained ESEC LLC's analysis of the Project's visibility impacts and responses to the District's comments on the Project's cumulative impacts. ESEC LLC anticipates that the Air District will make its decision on the Project's revised emissions in December 2013.
