Subject: Report of conversation and notice intent to reschedule the proposed September 16, 2020 Committee Conference to September 23, 2020 at 1:00 p.m.

On August 26, 2020 at about noon, Scott Galati, the attorney for the Applicant,¹ called hearing officer Ralph Lee and informed him that Mr. Galati has a schedule conflict for a Committee Conference on September 16, 2020. No formal notice of a September 16, 2020 Committee Conference has been issued, but the parties were asked to hold that date by the August 26, 2020 Hearing Officer Memorandum.² During the August 26, 2020 call, Mr. Galati requested rescheduling the Committee Conference to the week of September 21st. Mr. Galati stated that if rescheduling is not possible, Mr. Galati would make arrangements to attend the September 16, 2020 Committee Conference. Mr. Lee responded that he would see if there was anything the Committee can do.

The Committee now intends to reschedule the formerly proposed September 16, 2020 Committee Conference to the new date and time of September 23, 2020 at 1 p.m.

Parties may file any objection to rescheduling the Committee Conference to the new date and time of September 23, 2020 at 1 p.m., or may file notice of conflict, no later than noon on Monday, August 31, 2020.
