

## Section 1601. Scope.

...[skipping first paragraph through (f)]

(g) Pool heaters; portable electric spas; residential pool pump and motor combinations, and replacement residential pool pump motors; and pumps, dedicated-purpose pool pumps, and replacement dedicated-purpose pool pump motors ~~portable electric spas, and pumps.~~

## Section 1602. Definitions.

...[skipping (a) through (f)]

(g) Pool Heaters; Portable Electric Spas; Pumps, Residential Pool Pump and Motor Combinations, and Replacement Residential Pool Pump Motors; and Pumps, Dedicated-Purpose Pool Pumps, and Replacement Dedicated-Purpose Pool Pump Motors.

...[skipping (g)(1) through (g)(2)]

(3) Residential Pool Pump and Motor Combinations and Replacement Residential Pool Pump Motors Definitions. The following definitions apply to products manufactured before July 19, 2021.

1 ...[skipping “Capacitor start-capacitor run” through “Pool pump motor capacity”]

2 “Replacement residential pool pump motor” means a replacement motor marketed by a  
3 manufacturer intended to be coupled to an existing residential pool pump that is used to  
4 circulate and filter pool water in order to maintain clarity and sanitation.

5 ...[skipping “Residential pool pump” through rest of (g)(3)]

6 **(4) Pumps, Dedicated-Purpose Pool Pumps, and Replacement Dedicated-Purpose Pool Pump**  
7 **Motors Definitions.**

8 ...[skipping “Bare pump”]

9 “Basket strainer” means a perforated or otherwise porous receptacle, mounted within a housing  
10 on the suction side of a pump that prevents solid debris from entering a pump. The basket  
11 strainer receptacle is capable of passing spherical solids of 1 millimeter (mm) in diameter and  
12 can be removed by hand or using only simple tools such as a screwdriver, pliers, or an open-  
13 ended wrench.

14 ...[skipping “Basic model” through “Control”]

15 “Dedicated-purpose pool pump” comprises self-priming pool filter pumps, non-self-priming  
16 pool filter pumps, waterfall pumps, pressure cleaner booster pumps, integral sand-filter pool  
17 pumps, integral-cartridge filter pool pumps, storable electric spa pumps, and rigid electric spa  
18 pumps.

19 “Dedicated-purpose pool pump motor total horsepower” means the product of the dedicated-  
20 purpose pool pump nominal motor horsepower and the dedicated-purpose pool pump service  
21 factor of a motor used on a dedicated-purpose pool pump based on the maximum continuous  
22 duty motor power output rating allowable for the motor’s nameplate ambient rating and  
23 insulation class.

24 “Dedicated-purpose pool pump service factor” means a multiplier applied to the rated  
25 horsepower of a pump motor to indicate the percent above nameplate horsepower at which the  
26 motor can operate continuously without exceeding its allowable insulation class temperature  
27 limit.

28 “Designed and marketed” means that the equipment is designed to fulfill the indicated  
29 application and, when distributed in commerce, is designated and marketed for that  
30 application, with the designation on the packaging or any publicly available documents such as  
31 product literature, catalogs, and packaging labels.

32 ...[skipping “Driver” through “Fire pump”]

33 “Freeze protection control” means a pool pump or replacement motor control that, at a certain  
34 ambient temperature, turns on the dedicated-purpose pool pump or replacement motor to  
35 circulate water for a period of time to prevent the pool and water in plumbing from freezing.

36 ...[skipping “Full impellor diameter” through “In-line (IL) pump”]

1 “Integral” means a part of the device that cannot be removed without compromising the  
2 device’s function or destroying the physical integrity of the unit.

3 “Integral cartridge-filter pool pump” means a pump that requires a removable cartridge filter,  
4 installed on the suction side of the pump, for operation, and the cartridge filter cannot be  
5 bypassed.

6 “Integral sand-filter pool pump” means a pump distributed in commerce with a sand filter that  
7 cannot be bypassed.

8 ...[skipping Magnet-driven pump”]

9 “Maximum operating speed” means the rated full-load speed of a motor powered by a 60 Hertz  
10 (Hz) alternating current (AC) source. Speed is expressed in revolutions per minute (RPM).

11 ...[skipping Mechanical equipment through “Mechanically-coupled pump”]

12 “Multi-speed dedicated-purpose pool pump” means a dedicated-purpose pool pump that is  
13 capable of operating at more than two discrete, pre-determined operating speeds separated by  
14 speed increments greater than 100 revolutions per minute (RPM), where the lowest speed is less  
15 than or equal to half of the maximum operating speed and greater than zero, and must be  
16 distributed in commerce with an on-board pool pump control (i.e., variable speed drive and  
17 user interface or programmable switch) that changes the speed in response to pre-programmed  
18 user preferences and allows the user to select the duration of each speed or the operational  
19 times or both.

20 ...[skipping “Non-continuous control]

21 “Non-self-priming pool filter pump” means a pool filter pump that is not certified under  
22 NSF/ANSI 50-2015, “Equipment for Swimming Pools, Spas, Hot Tubs and Other Recreational  
23 Water Facilities”, to be self-priming and is not capable of re-priming to a vertical lift of at least  
24 5.0 feet with a true priming time less than or equal to 10.0 minutes, when tested in accordance  
25 with section 1604(g)(4)(B) of this Article, and is not a waterfall pump.

26 ...[skipping “PEI<sub>cl</sub>” through “PEI<sub>vl</sub>”]

27 “Pool filter pump” means an end suction pump that:

28 (A) either:

29 1. includes an integrated basket strainer; or

30 2. does not include an integrated basket strainer, but requires a basket strainer for  
31 operation, as stated in manufacturer literature provided with the pump; and

32 (B) may be distributed in commerce connected to, or packaged with, a sand filter, removable  
33 cartridge filter, or other filtration accessory, provided that the filtration accessory is  
34 connected with consumer-removable connections that allow the filtration accessory to be  
35 bypassed.

1 “Pool pump timer” means a pool pump control that automatically turns off a dedicated-purpose  
2 pool pump after a run-time of no longer than 10 hours.

3 “Pressure cleaner booster pump” means an end suction dry rotor pump designed and marketed  
4 for pressure-side pool cleaner applications, and which may be UL listed under UL 1081-2016,

5 ...[skipping Prime-assist pump” through “Radially split, multi-stage, vertical, in-line diffuser  
6 casing (RSV) pump”]

7 “Removable cartridge filter” means a filter component with fixed dimensions that captures and  
8 removes suspended particles from water flowing through the unit. The removable cartridge  
9 filter is not capable of passing spherical solids of 1 mm in diameter or greater, and can be  
10 removed from the filter housing by hand or using only a simple tool such as a screwdriver,  
11 plier, or open-ended wrench.

12 “Replacement dedicated-purpose pool pump motor” means an electric motor that:

13 (A) is single-phase or polyphase;

14 (B) has a dedicated purpose pool pump motor total horsepower of less than or equal to 5  
15 horsepower;

16 (C) is marketed for use as a replacement motor in self-priming pool filter pump, non-self-  
17 priming pool filter pump, or pressure cleaner booster pump applications; and

18 (D) excludes polyphase replacement dedicated-purpose pool pump motors capable of  
19 operating without a drive, and is sold or offered for sale without a drive that converts  
20 single-phase power to polyphase power.

21 “Rigid electric spa pump” means an end suction pump that does not contain an integrated  
22 basket strainer or require a basket strainer for operation as stated in manufacturer literature  
23 provided with the pump and that meets the following three criteria:

24 (A) is assembled with four through bolts that hold the motor rear endplate, rear bearing,  
25 rotor, front bearing, front endplate, and the bare pump together as an integral unit;

26 (B) is constructed with buttress threads at the inlet and discharge of the bare pump; and

27 (C) uses a casing or volute and connections constructed of a non-metallic material.

28 ...[skipping “Rotodynamic pump”]

29 “Sand filter” means a device designed to filter water through sand or an alternate sand-type  
30 media.

31 “Self-priming pool filter pump” means a pool filter pump that is certified under NSF/ANSI 50-  
32 2015, to be self-priming or is capable of re-priming to a vertical lift of at least 5.0 feet with a  
33 true priming time less than or equal to 10.0 minutes, when tested with section 1604(g)(4)(B) of  
34 this Article, and is not a waterfall pump.

35 ...[skipping “Self-priming pump” through “Single axis flow pump”]

1 "Single-speed dedicated-purpose pool pump" means a dedicated-purpose pool pump that is  
2 capable of operating at only one speed.

3 "Storable electric spa pump" means a pump that is distributed in commerce with the following:  
4 (A) an integral heater; and  
5 (B) an integral air pump.

6 "Submersible pump" means a pump that is designed to be operated with the motor and bare  
7 pump fully submerged in the pumped liquid.

8 ...[skipping "Submersible turbine (ST) pump through "Twin head pump"]

9 "Two-speed dedicated-purpose pool pump" means a dedicated-purpose pool pump that is  
10 capable of operating at only two different pre-determined operating speeds, where the low  
11 operating speed is less than or equal to half of the maximum operating speed and greater than  
12 zero, and is distributed in commerce either:

13 (A) with a pool pump control (e.g., variable speed drive and user interface or switch) that is  
14 capable of changing the speed in response to user preferences; or

15 (B) without a pool pump control that has the capability to change speed in response to user  
16 preferences, but is unable to operate without the presence of such a pool pump control.

17 "Variable-speed dedicated-purpose pool pump" means a dedicated-purpose pool pump that is  
18 capable of operating at a variety of user-determined speeds, where all the speeds are separated  
19 by at most 100 revolutions per minute (RPM) increments over the operating range and the  
20 lowest operating speed is less than or equal to one-third of the maximum operating speed and  
21 is greater than zero. Such a pump must include a variable speed drive and be distributed in  
22 commerce either:

23 (A) with a user interface that changes the speed in response to pre-programmed user  
24 preferences and allows the user to select the duration of each speed and/or the on and off  
25 times; or

26 (B) without a user interface that changes the speed in response to pre-programmed user  
27 preferences and allows the user to select the duration of each speed and/or the on and off  
28 times, but is unable to operate without the presence of a user interface.

29 "Variable speed drive" means equipment capable of varying the speed of the motor.

30 "Variable-speed replacement dedicated-purpose pool pump motor" means a replacement  
31 dedicated-purpose pool pump motor that is capable of operating at a variety of user-  
32 determined speeds, where all the speeds are separated by at most 100 revolutions per minute  
33 (RPM) increments over the operating range and the lowest operating speed is less than or equal  
34 to one-third of the maximum operating speed and is greater than zero. Such a motor must  
35 include a variable-speed drive and be sold or offered for sale either:

1 (A) with a user interface that changes the speed in response to preprogrammed user  
2 preferences and allows the user to select the duration of each speed, the operational times,  
3 or both; or

4 (B) without a user interface that changes the speed in response to preprogrammed user  
5 preferences and allows the user to select the duration of each speed, the operational times,  
6 or both, but is unable to operate without the presence of such a user interface.

7 “Waterfall pump” means a pool filter pump with a certified maximum head less than or equal  
8 to 30.0 feet, and a maximum speed less than or equal to 1,800 revolutions per minute (RPM).

13 (B) ANSI/HI 1.6-2000 shall be used for the measurement of pump efficiency.

14 (C) Three curves shall be calculated:

15 Curve A:  $H = 0.0167 \times F^2$

16 Curve B:  $H = 0.050 \times F^2$

17 Curve C:  $H = 0.0082 \times F^2$

18 Where:

19 H is the total system head in feet of water.

20 F is the flow rate in gallons per minute (gpm).

21 (D) For each curve (A, B, or C), the pump head shall be adjusted until the flow and head lie  
22 on the curve. The following shall be tested and reported (i) for each curve for single-  
23 speed pumps or (ii) for each curve at both highest and lowest speeds for two-, multi-, or  
24 variable-speed pumps:

25 1. Motor nominal speed (RPM)

26 2. Flow (gallons per minute)

27 3. Power (watts and volt amps)

28 4. Energy Factor (gallons per watt hour)

29 Where the Energy Factor (EF) is calculated as:

30  $EF = \text{Flow (gpm)} \times 60 / \text{Power (watts)}$

1 (43) Test Methods for Pumps, Dedicated-Purpose Pool Pumps, and Replacement Dedicated-

3 (A) The test method for pumps, except for dedicated-purpose pool pumps, is 10 C.F.R.  
4 section 431.464(a) (Appendix A to subpart Y of part 431).

5 (B) The test method for dedicated-purpose pool pumps manufactured on or after July 19,  
6 2021 and served by single-phase or polyphase input power, is 10 C.F.R. 431.464(b)  
7 (Appendix C to subpart Y of part 431).

8 (C) A replacement dedicated-purpose pool pump motor manufactured on or after July 19,  
9 2021, shall be tested in accordance with CSA-C747-09 (Reaffirmed 2014), "Energy  
10 Efficiency Test Methods for Small Motors" at full load and maximum operating speed. If  
11 a drive is sold or offered for sale with the replacement dedicated-purpose pool pump  
12 motor, the input power of the drive while the drive is connected to the motor shall be  
13 used to determine nominal efficiency and power factor per the test procedure.

14 1. Motor torque shall be recorded in lb-ft, motor speed in rotations per minute, and  
15 input power shall be recorded in watts.

16 2. Power factor shall be calculated as:

17 Single phase motors:

18 Power Factor (%) = 100 x Input Power (W)/(Voltage(V) x Amps (A))

19 Three phase motors:

20 Power Factor (%) = 100 x Input Power (W)/(Voltage(V) x Amps(A) x 1.73)

21 where Voltage and Amps are the measured root mean square (rms) voltage and current.

3 (C) Each integral cartridge-filter pool pump and integral sand-filter pool pump that is  
 4 manufactured on or after July 19, 2021, shall be distributed in commerce with a  
 5 pool pump timer that is either integral to the pump or a separate component that is  
 6 shipped with the pump.

7 (D) For all dedicated-purpose pool pumps manufactured on or after July 19, 2021, with  
 8 freeze protection controls, the pump shall be shipped with freeze protection  
 9 disabled or with all of the following default, user-adjustable settings:

- 10 1. the default dry-bulb air temperature setting shall be no greater than 40 °F;  
 11 2. the default run time setting shall be no greater than 1 hour (before the  
 12 temperature is rechecked); and  
 13 3. the default motor speed shall not be more than one half of the maximum  
 14 available speed.

15 (E) Waterfall pumps. There is no energy efficiency standard for waterfall pumps. See
