NEMA Comments on CEC Proposed Repeal of Title 20 Self-Contained Lighting Controls Requirements and Other Amendments

Dear Commissioner McAllister:

As the leading trade association representing manufacturers of lighting controls, the National Electrical Manufacturers Association (NEMA) submits these comments on the proposed repeal of regulatory requirements for self-contained lighting controls and other amendments. These comments are submitted on behalf of NEMA Lighting Controls Section Member companies.

NEMA represents approximately 325 electrical equipment and medical imaging manufacturers that make safe, reliable, and efficient products and systems across 58 product Sections. Our combined industries account for 370,000 American jobs in more than 6,100 facilities covering every state. Our industry produces \$124 billion electrical equipment and medical imaging shipments per year with \$42 billion exported.

NEMA supports the proposed repeal which will eliminate redundant regulatory requirements between Title 24 and Title 20 and therefore reduce the potential for confusion and misunderstanding of these provisions. The repeal will improve understanding of and compliance with regulatory requirements for self-contained lighting controls.
