Purpose

The California Energy Commission (CEC) has posted this locally adopted energy standard for a mandatory public review period, per California Code of Regulations, Title 24, Part 1, Chapter 10, Section 10-106 and Section 10-110. The application has been determined to be complete by CEC staff, including all the supporting information necessary to meet the requirements of Section 10-106. The CEC seeks public comments on whether the locally adopted energy standard will consume less energy than the *2019 California Energy Code*, California Code of Regulations, Title 24, Part 6 (Energy Code).

Background

Statutory provisions in Public Resources Code Section 25402.1(h)(2) and regulatory provisions in Section 10-106 of Title 24, Part 1 (2019 California Administrative Code) establish a process that allows local governmental agencies to adopt and enforce energy standards for newly constructed buildings, additions, alterations, and repairs to existing buildings. The CEC must find that the local standards will require buildings to be designed to consume no more energy than permitted by the Energy Code.

Local governmental agencies are required to apply to the CEC for approval prior to enforcement of such standards. Its application must include the basis of the local government's determination that its standards are cost-effective and the supporting analysis for how the local government has determined its proposed energy standards will consume less energy than the current Energy Code. The CEC must then find, based on the submitted application materials, that the standards will result in a reduction in energy consumption compared to the statewide Energy Code.

Written comments should be submitted by: **5:00 p.m. on Monday, December 28, 2020.**
