REMAINDER OF PROCEEDING

These options assume that the South Coast Air Quality Management District's ("SCAQMD") Final Determination of Compliance ("FDOC") is published on or before September 16, 2016 to provide Commission Staff time to incorporate any changes from the FDOC. If the FDOC is not published prior to the issuance of the Final Staff Assessment ("FSA"), an FSA errata, if necessary, can be published after the issuance of the FDOC. Alternatively, the FDOC can be entered into evidence at the evidentiary hearing, and the conditions of certification incorporated into the Presiding Member's Proposed Decision ("PMPD") per the terms of the *Approved ARB-CEC Joint Policy Statement of Compliance with Air Quality Laws By New Power Plants*.¹ These options also assume that a special Business Meeting is scheduled for consideration of the PMPD by the full Commission.
