## Subject: INTERVENOR SARVEY'S EVIDENTIARY HEARING QUESTIONS AND SCHEDULE UPDATE

On April 12, 2021, the California Energy Commission (CEC) Committee<sup>1</sup> filed its <u>Notice</u> of <u>Prehearing Conference</u>, <u>Evidentiary Hearing</u>, <u>Scheduling Order</u>, and <u>Related Orders</u> (Notice and Orders). The Notice and Orders contained directions to the parties about the method of conducting cross-examination. The parties were directed to file written cross-examination questions no later than April 30, 2021. The questions were to "identify the issue(s) that require a factual determination by the Committee and the **identity of the witness(es)**" (emphasis added).

In <u>Intervenor Sarvey's Evidentiary Hearing Questions</u>, Intervenor Robert Sarvey asked a series of questions concerning various topics. However, Mr. Sarvey neither identified any witness to whom the question was directed nor specified which party should answer the question.

Accordingly, Mr. Sarvey is directed to file revised questions that, at a minimum, specify the party to whom the question is directed and, where possible, identify the specific witness. For witness names and their areas of expertise, please see Section 6 and Attachment B to the <a href="Compiled Revised IS/PMND">Compiled Revised IS/PMND</a> for CEC staff and <a href="C1 SBGF Opening Testimony Package">C1 SBGF Testimony Responding to Committee Questions on Air Quality</a>, and <a href="C1 SBGF Supplemental Rebuttal Testimony">C1 SBGF Supplemental Rebuttal Testimony</a> for Applicant. Mr. Sarvey's revised questions containing the above information shall be filed **no later than 12:00 p.m. on May 4, 2021.** 

The Notice and Orders currently require that responses to cross-examination be filed on May 5, 2021, and Exhibit Lists be filed on May 7, 2021. These deadlines are hereby extended. The parties shall file responses to cross-examination questions **no later than 3:00 p.m. on May 7, 2021.** All parties shall file exhibit lists **no later than 12:00 p.m. on May 10, 2021.**
