Proposed Ventilation Guidelines

Initial phase: Assessment and Maintenance Grants

- Planned Projects or Reimbursements for work after 8/1/2020

- Assessment
- Maintenance
- Adjustments of ventilation rates
- Filter replacements
- Carbon dioxide monitor installation
- Assessment report

Possible future phase: HVAC Upgrade and Repair Grants

- HVAC repairs, upgrades, or replacements



Maximum Award Update

Eligible Items	Previous Maximum Award Amount	Revised Maximum Award Amount
HVAC Assessment and Maintenance and HVAC Assessment Report	\$40,000	\$10,000 plus \$1,000 / HVAC unit
CO2 Monitors	\$500 / monitor	\$600 / monitor
Filters	\$75 / filter	No change

- 20% contingency revised to include assessment, CO2 monitors, and filters



Staff Recommendation
