- 4 MS. LOPEZ: Good morning everyone. My
- 5 name is Jessica Lopez. I'm an Engineer in the
- 6 Appliances Office in the Commission's Efficiency
- 7 Division. I want to welcome everybody to the
- 8 public hearing for Portable Electric Spas
- 9 Proposed Amendments.
- 10 So here are just a few housekeeping
- 11 rules. All lines will be muted until after the
- 12 presentation. Following the presentation, we'll
- 13 take public comments. If you have any general
- 14 clarifying questions, you can type those in the
- 15 O&A section.
- 16 For any kind of public comments related
- 17 to the proposed regulations, please raise your
- 18 hand to speak and the host will give you the
- 19 ability to speak, and then you can un-mute
- 20 vourself.
- If you're on a cell phone, you can raise
- 22 your hand by dialing star nine. The host will
- 23 give you the ability to speak. And then you can
- 24 dial star six to mute or un-mute yourself.
- 25 And then before commenting, please, state

- 1 your name and affiliation for the record.
- 2 So this public hearing is being held
- 3 pursuant to the California Administrative
- 4 Procedure Act, Government Code section 11346.8.
- 5 It is being held online due to COVID-19 Public
- 6 Health Order.
- 7 The purpose of the public hearing is to
- 8 collect oral comments for review and
- 9 consideration related to the Portable Electric
- 10 Spas proposed amendments. We will be collecting
- 11 comments but we will not be responding to
- 12 comments today.
- 13 The public hearing is being recorded by a
- 14 Court Reporter and all statements become part of
- 15 the public record.
- 16 Hear is just a brief overview of the
- 17 history of this rulemaking.
- 18
- 19 On August 19, 2020, the Energy Commission
- 20 adopted an order instituting rulemaking to
- 21 initiate the rulemaking.
- 22 Then, on May 14, 2021, the Energy
- 23 Commission released initial rulemaking documents,
- 24 such as the Notice of Proposed Action, Initial
- 25 Statement of Reasons, the Economic and Fiscal

- 1 Impact Statement, the proposed regulatory
- 2 language, and a Staff paper.
- 3 On June 28th, 2021, which was yesterday,
- 4 the 45-day comment period closed. Today, we are
- 5 holding a public hearing to collect comments.
- 6 And on July 15, 2021, Staff will be
- 7 seeking approval from the Energy Commission to
- 8 adopt the proposed regulations. At this business
- 9 meeting there will also be an opportunity to
- 10 comment on this rulemaking.
- 11 Copies of the rulemaking documents are
- 12 available online in Docket 20-AAER-04.
- So next, I'll provide an overview of the
- 14 proposed amendments for portable electric spas.
- Before, and just to give you some
- 16 background, in 2018 the Energy Commission adopted
- 17 changes to Title 20 amending the Appliance
- 18 Efficiency Regulations for Portable Electric
- 19 Spas. The amendments included expanding the
- 20 scope, more stringent efficiency standards for
- 21 standard, exercise and combination spas, a
- 22 separate efficiency standard for inflatable spas,
- 23 test procedure modifications to accommodate that
- 24 expanded scope of products, and a labeling
- 25 requirement which was modified to be California-

- 1 specific to standardize the label. These
- 2 amendments were based on the 2014 version of the
- 3 industry standard APSP-14 but were modified to
- 4 exceed requirements specified or to add
- 5 clarification.
- 6 In 2019 the revised standard was
- 7 published, incorporating the regulations adopted
- 8 in 2018 by the CEC.
- 9 The 2019 version of APSP-14 aligns with
- 10 California Efficiency Standards for Portable
- 11 Electric Spas in effect today. With that, we are
- 12 proposing to amend existing regulations for
- 13 portable electric spas to update the test
- 14 procedure reference, which includes simplifying
- 15 the certification process for test laboratories
- 16 and the labeling design requirements to align
- 17 with industry standards. Additional changes are
- 18 being proposed to simplify the structure of
- 19 existing regulations. There are some differences
- 20 but none that effect the performance standard or
- 21 the test method for determining the efficiency of
- 22 spas.
- So, specifically, we are proposing to
- 24 update the test procedure reference from the 2014
- 25 version of APSP-14 with modifications to the 2019

- 1 version of APSP-14 with no modification. And
- 2 then we're also amending the label design from a
- 3 California-specific label to a universal label.
- 4 That concludes my presentation. We will
- 5 begin taking public comments. And just remember
- 6 to state your name and organization for the
- 7 record. And again, if you would like to make a
- 8 comment, please raise your hand, or type in your
- 9 comment in the Q&A.
- 10 (Pause)
- 11 MS. LOPEZ: I'm not seeing any raised
- 12 hands yet. We will stay on the line,
- 13 approximately until 10:30. If anyone wants to
- 14 make a comment, you can.
- I see one raised hand, Tony Sadati.
- 16 Hopefully, I said that right.
- 17 Tony? You might be muted.
- MR. SADATI: Can you hear me?
- MS. LOPEZ: Yes, we can hear you.
- 20 MR. SADATI: Yes. My name is Tony
- 21 Sadati. We're a portable spa manufacturer. I
- 22 represent four brands, Sundance Spa, Jacuzzi Hot
- 23 Tubs, Dimension One, and Thermal Spas. And we
- 24 fully support this requirement to change to the
- 25 latest addition of the APSP-14. I just wanted to

- 1 say that.
- Thank you.
- 3 MS. LOPEZ: Thank you.
- 4 (Pause)
- 5 MS. LOPEZ: So we just received one
- 6 comment and I want to read it out loud for the
- 7 Court Reporter. This is from Nathan Coelho from
- 8 Master Spas. He says,
- 9 "Thanks for all of the work getting this to
- 10 where it is today. We support the changes
- 11 proposed here."
- 12 (Pause)
- 13 MS. LOPEZ: So we just received another
- 14 comment in the chat box and I want to read it out
- 15 loud for the Court Reporter. It says,
- 16 "Hello. This is Marisa Lee from Energy
- 17 Solutions on behalf of the California Owned
- 18 Utilities," in quotes, "'PG&E, SCE and
- 19 SDG&E.' The California IOUs support the
- 20 Energy Commission's proposed updates to the
- 21 Portable Electric Spas test procedures and
- 22 labeling requirements and thank the Energy
- 23 Commission for the opportunity to be involved
- in this process."
- 25 Thank you, Marisa, for your comment.
