**PRESIDING MEMBER'S RULING RE: INTERVENOR'S MOTION TO POSTPONE

INTRODUCTION

On December 9, 2016, Intervenor, Los Cerritos Wetlands Land Trust (LCWLT), filed a Motion To Postpone Opening Testimony, Rebuttal, and Pre-Hearing Conference Statement (Motion) seeking to extend the deadline¹ to file Opening Testimony from December 14, 2016 to December 16, 2016; Rebuttal Testimony from December 16, 2016 to December 20, 2016; Pre-Hearing Conference Statement from December 19, 2016 to December 30, 2016; and the Evidentiary Hearing from December 20, 2016 to the first week of January, 2017.²

No objections to LCWLT's Motion have been filed to date, however, the 14 days allowed for responses to motions has not elapsed as of the date of this Order.³ In light of the impending deadlines, the Presiding Member makes the following ruling on the Motion.

ORDER

LCWLT's Motion to extend the deadline to file Opening Testimony from December 14, 2016 to December 16, 2016 is **GRANTED**. All other requested date changes to the schedule are **DENIED**, except that the deadline to submit Rebuttal Testimony is extended from December 16, 2016 to December 19, 2016 before noon.
