## **PURPOSE OF THE COMMITTEE CONFERENCE**

The purpose of this Committee Conference is to review the current status of the proceeding, to address any outstanding issues, and to develop a schedule for the proceeding. In addition to the formal parties, the Committee invites the attendance of interested public agencies and the public. We direct the parties’ attention to the section “**ORDERS REGARDING ISSUES IDENTIFICATION, STATUS REPORTS, PROPOSED SCHEDULE, AND PRESENTATIONS BY APPLICANT, STAFF, AND THE PUBLIC ADVISOR,**” below, regarding their expected participation in and responsibilities for the conference.

## **BACKGROUND AND DESCRIPTION OF PROPOSED PROJECT**

### ***Small Power Plant Exemptions***

The CEC has the exclusive authority to consider, and ultimately approve or deny, applications for the construction and operation of thermal power plants that will generate 50 megawatts (MW) or more of electricity.<sup>4</sup> The CEC may grant an exemption to its certification jurisdiction—the SPPE—for thermal powerplants generating between 50 and 100 MW.

To grant an SPPE, the CEC must make three distinct determinations:

- the proposed powerplant has a generating capacity up to 100 MW;
- no substantial adverse impact on the environment will result from the construction or operation of the powerplant; and
- no substantial adverse impact on energy resources will result from the construction or operation of the powerplant.<sup>5</sup>

The CEC must also make the latter two findings as the “lead agency”<sup>6</sup> under the California Environmental Quality Act (CEQA).<sup>7</sup>

The SPPE process provides a public forum allowing the applicant requesting the exemption, CEC staff (Staff), intervenors, governmental agencies, and members of the public to participate in the decision-making process.

If an SPPE is granted, responsible local land use authorities and other agencies, most notably any local air management or air pollution control district, conduct further review of the project, including any necessary environmental review under CEQA.

### ***Proposed Project***<sup>8</sup>

The proposed project site is located at 2590 Walsh Avenue in the City of Santa Clara, Santa Clara County, California (Project Site). The Project Site is currently developed with an approximately 115,000 square foot single-story office and warehouse building and associated paved surface parking and loading dock. These improvements would be demolished in order to construct the proposed project.

The Applicant proposes to construct and operate the CA3 Data Center (Data Center), and the CA3 Backup Generating Facility (Backup Generating Facility) (collectively, the “Proposed Project”). The Data Center would consist of a four-story, 469,482 square foot data storage center building, which would provide secure and environmentally controlled structures to house computer servers.

The Backup Generating Facility would ensure reliability to the Data Center in the event of loss of power from Silicon Valley Power (SVP), the local utility provider, and normally would operate only for testing and maintenance. The Backup Generating Facility would consist of 44 diesel-fired backup generators each with a maximum peak rating of 2.75 MW, located in an on-site generator equipment yard. Four of these generators would be used to support redundant critical cooling equipment and other general building and life safety services. None of the generators will be interconnected to the electrical transmission system, and therefore no electricity can be delivered off site. The Backup

Generating Facility would supply power only to the Data Center. The maximum electrical demand of the Data Center is 96 MW.

The Applicant also proposes to construct an electrical substation along the western boundary of the Project Site, adjacent to the existing SVP Uranium substation. The new substation will cut-in to the existing 60kV line passing nearby and switching will occur at the Uranium substation.

CEQA requires the CEC to consider the “whole of an action.”<sup>9</sup> Therefore, the CEC will include the Data Center, the Backup Generating Facility, and the substation in its environmental analysis.

### **ORDERS REGARDING ISSUES IDENTIFICATION, STATUS REPORTS, PROPOSED SCHEDULE, AND PRESENTATIONS BY APPLICANT, STAFF, AND THE PUBLIC ADVISOR**

To assist the Committee, parties, participating agencies, and members of the public in understanding the Proposed Project, Staff shall file an Issues Identification Report, Status Report, and Proposed Schedule, summarizing the major issues identified to date, reporting the status on activities conducted to date and issues that require resolution before hearings can be conducted, and proposing a schedule for the conduct of this proceeding. This report will also indicate what additional information is necessary to resolve issues of concern. Staff shall file its Issues Identification Report, Status Report, and Proposed Schedule **no later than August 2, 2021**. Applicant shall file a response to the Issues Identification Report, Status Report, and Proposed Schedule **no later than August 6, 2021**.

Copies of these documents will be posted to the online docket for this proceeding.

Applicant shall be prepared to offer an overview of the Proposed Project at the Committee Conference. Staff shall also be prepared to offer an overview of its Issues Identification Report, Status Report, and Proposed Schedule. Overviews may include presentations and should not be longer than 15 minutes.

The Public Advisor’s Office is invited to provide a brief overview of the function of the Public Advisor’s Office regarding this proceeding and opportunities for public participation in this proceeding.
