The California Energy Commission (CEC) will jointly conduct a workshop with the California Public Utilities Commission (CPUC) and the California Independent System Operator (California ISO) to discuss an approach to examine potential environmental and land use implications of developing renewable energy resources required to achieve the goals of Senate Bill 100 (SB 100).

The CEC commissioners participating in the workshop are Commissioner Karen Douglas, lead commissioner for the Siting, Transmission, and Environmental Protection Division, and Commissioner Siva Gunda, lead commissioner for the Energy Assessments Division. A quorum of CEC commissioners may participate, but no votes will be taken. Commissioners from the CPUC may also attend. If CPUC commissioners are present at the workshop, the CPUC's rules governing ex parte contacts with commissioners and their staff remain in effect although this is a CEC-initiated and noticed workshop.

This workshop will be held remotely, consistent with Executive Order N-08-21 to continue to help California respond to, recover from, and mitigate the impacts of the COVID-19 pandemic. The public can participate in the hearing consistent with the direction in the executive order.

Agenda

Staff from the CEC, CPUC, and California ISO will present and lead discussions on the development of a resource map that will assist in examining the potential environmental and land use implications of build-outs of renewable energy resources modeled to meet SB 100 goals. The selected SB 100 scenarios and the resource map will also help inform work on the California ISO 20-year Transmission Outlook. The agenda will include time for a questions and answers period with workshop participants and a general public comment period.

Background

The 100 Percent Clean Energy Act of 2018 (SB 100, De León, Chapter 312, Statutes of 2018) establishes a target for renewable and zero-carbon resources to supply 100 percent of retail sales and electricity procured to serve all state agencies by 2045. SB 100 requires the CEC, CPUC, and California Air Resources Board to develop and submit a joint-agency report to the legislature by January 1, 2021, and at least every four years thereafter. The final joint-agency report published on March 15, 2021¹ recommends updates of land use information to reflect the increased resource requirements of SB 100; to further consider the potential impact of emerging resources and technologies, and to integrate into SB 100 planning the social costs and non-energy benefits of land-use impacts, public health, air quality, water supply and quality, economic impacts, and resilience.

Effectively integrating 100 percent renewable and zero-carbon technologies and achieving carbon neutrality in California by 2045 will require rigorous analysis of implementation considerations and coordinated planning across state agencies. Statewide planning will ensure that California has a safe and reliable electricity system as new renewable and zero-carbon resource and transmission infrastructure is developed, consistent with the state's clean energy and environmental priorities and goals.
