# **UPDATE OF THE INITIAL STATEMENT OF REASONS**

There were several minor non-substantive changes made to align the text with existing text.

There was a non-substantive change made to Section 1605.3 (g)(7)(A) deleting the text "manufactured on or after June 1,2019" for consistency with other text on the manufacture date.

There was a non-substantive change made to Section 1605.3 Table G-5 to change "( -5.6 degrees Celsius to 12.2 degrees Celsius) to correct an incorrect calculation based on the test procedure.

#### LOCAL MANDATE DETERMINATION

The California Energy Commission has determined that this action will not result in a local mandate on local agencies or school districts.

## **CONSIDERATION OF ALTERNATIVE PROPOSALS**
