The California Energy Commission (CEC) is holding an *en banc* meeting of CEC and California Public Utilities Commission (CPUC) Commissioners on the Electric Program Investment Charge 2021-2025 Investment Plan (EPIC 4 Investment Plan). At this meeting, CEC and CPUC Commissioners will share their perspectives and priorities on the proposed funding initiatives in the EPIC 4 Investment Plan. A guorum of Commissioners may participate, but no votes will be taken.

The en banc meeting will be held remotely, consistent with Assembly Bill 361 (Rivas, Chapter 165, Statutes of 2021) to improve and enhance public access to state meetings during the COVID-19 pandemic and future emergencies by allowing broader access through teleconferencing options. The public can participate in the *en banc* meeting consistent with the direction provided in this notice. Instructions for remote participation via Zoom and telephone are below. Please note that the CEC aims to begin promptly at the start time indicated and the end time is an estimate based on the proposed agenda. The en banc meeting may end sooner or later depending on various factors.

Agenda

CEC Chair David Hochschild, CEC Commissioner Andrew J. McAllister, and CPUC Commissioner Martha Guzman Aceves will make introductory remarks. Staff will provide a snapshot of CEC's past 10 years of research and development (R&D) accomplishments and benefits provided to California through EPIC. This will be followed by an overview of the CEC's proposed strategic initiatives in the EPIC 4 Investment

Plan. CEC and CPUC Commissioners will then discuss the proposed initiatives and offer their perspectives and priorities for advancing California's clean energy policies. The *en banc* meeting will conclude with an opportunity for public comment.

Background

In 2012, the CPUC established EPIC to fill a critical gap in funding for public investments in clean energy research and technology innovation that can provide benefits to electric ratepayers through greater reliability, lower costs, and increased safety. The CPUC selected the CEC and the state's three largest investor-owned utilities (IOUs) to administer EPIC. Senate Bill 96 (SB 96, Committee on Budget and Fiscal Review, Statutes of 2013) provides additional statutory direction in the CEC's administration of EPIC. Specifically, SB 96 directs the CEC to award EPIC funds for projects that will benefit electricity ratepayers and lead to technological advancement and breakthroughs to overcome the barriers that prevent achieving the state's statutory energy goals.

On September 2, 2020, the CPUC renewed EPIC for an additional ten years (January 1, 2021 through December 31, 2030) in Decision 20-08-042 of Rulemaking 19-10-005. In Decision 20-08-042, the CPUC approved the CEC as an EPIC administrator with an annual budget of \$148 million for the first five years and ordered the IOUs to collect funds for the renewed EPIC starting January 1, 2021.

The CPUC's Decision 20-08-042 requires the CEC to file an investment plan to the CPUC to cover the period of January 1, 2021, to December 31, 2025 (referred to as EPIC 4).
